ENTRY REQUIREMENTS

Entries must be delivered in person (no mail) on December 6, 2011, from 1-5 pm, at the PVCC Performing Arts Center lobby. Located at 32nd Street and Union Hills Drive, Phoenix, Arizona.

Entries: No more than three (3) entries per applicant. Submissions cannot have been previously exhibited or published. Similar images are considered to be the same image. Street art shows are not considered an exhibition. No images larger than 20 inches in any one direction. For submissions, “photographic” prints only. No images submitted on CD, thumb drive, memory cards, transparencies, etc. Framed images will not be accepted. **All images must be matted or mounted.** Unmounted or unmatted prints will not be accepted. Traditional photographs and digital images in color or black & white are eligible.

Juror: There will be one judge/juror who will have a background in professional photography. Any image is acceptable, however as this is a “Photography” competition, images showing a high amount of computer manipulation will not be considered in a positive manner. Judging will be based on technical quality, aesthetic quality and presentation.

Submissions: All submissions are to be in the form of color or black and white prints, (Giclee’s are acceptable) Submissions in any other form will not be accepted. No image is to be framed. All images are to be either matted, on a board, or have stretcher bars.

Labels: Clearly label the back of each image with the title and your initials
Approximately 1”x 4” label size.

Delivery: Hand delivery only on December 6, 2011 from 1 PM to 5 PM at the PVCC, Performing Arts Center lobby.

Return of Entries: Pick up of entries will only be on January 19, 2012 from 12 – 5 PM at the PVCC, Performing Arts Center. Any image left at after this date becomes the property of Paradise Valley Community College. No exceptions.

Liability: Paradise Valley Community College, staff or judges are not liable for any image submitted. Even while in transit, during return, or while in possession of the images.

A release agreeing to such must be signed by the applicant or their parent/guardian.

Exhibition Dates: Any image chosen for display will be shown in the Paradise Valley Community College, Performing Arts Center Lobby from December 8, 2011 through January 18, 2012.

Copyright: All images submitted must be the sole property of the applicant and are to be from an original image made by the applicant. A copyright release must be signed by the applicant and /or by their parent/guardian.

Winners: Winners and Prizes will be announced during the closing reception on January 18, 2012 from 5-7 pm.
